Proposed Budget Overview 2024-2025

Dear Community Members,

Enclosed is key budget information.

The budget process allowed us to look at our spending and revenues to present a well-planned and responsible budget to our taxpayers in support of the education of our students. Our Board of Education, on April 16, adopted a school budget in the amount of \$9,561,777. State Budget Projections include an increase in aid to our district. With a commitment of fiscal responsibility the Board of Education, Administration, Staff and Faculty have done more with less over the past few years. Our efforts to maintain a high quality education for our students is still our top priority. This year's spending plan is based on a tax levy increase of 1.99% which reflects a \$33,895 total local dollar increase district wide. This is below the property tax cap limit allowed. The budget allows for a proper balance of a stable environment and culture for our staff & students, with realistic requests for our taxpayer support is very important. Proposed Budget in Review

The Crown Point School Board continues to make important fiscal decisions. This has allowed us to stabilize our funding, taxpayer support and programs for our students. There are many factors that have contributed to our overall financial ability to meet the needs of our students.

An overview of the proposed budget:

- Support For Academic Learning Loss


How much will my taxes increase?

We look to you to continue to support the Crown Point Central School community based on our previous efforts to remain fiscally responsible. The proposed tax levy increase is 1.99%, under the tax cap allowed.

In terms of dollars and cents, the tax rate on a home assessed at \$100,000 would increase by approximately:

- · \$0.200 per thousand
- \$20.00 per year
- \$1.67 per month
- 5 cents per day

The actual amount of any tax increase is determined by the total tax assessments and the final equalization rates.

- Maintain our National Model School and School of Distinction Status


More Information Available


